



The Surrey County Inter-Club Four-Ball Competition 2019 (The Kelso Hamilton Trophy)

All Surrey Championships are governed by the Regulations of Surrey Golf as published in the Year Book, copies of which are held by Club Secretaries.

Summary of Regulations

1. Eligibility	A Club must be affiliated to Surrey County Golf.
2. Qualifications	The Players must be 18 years of age or over on 1 st January 2019. The Players must have handicaps of between 13 and 18 inclusive. No player may represent more than one Club in any Surrey team event in any calendar year. ALL PLAYERS MUST HAVE ACTIVE HANDICAPS.
3. Conditions of Play	The competition will be a knockout over 18 holes match play, four-ball, better ball off handicap. A Club may enter 1 or 2 Teams.
4. Play by date	Failure to play the match by the date shown on the County website may result in disqualification of both teams. Results must be notified by the winning team, to the County Office immediately the match has been played, via e-mail.
5. Entry Fee	All Entry Forms must be accompanied by an Entry Fee of £27.00 per team.
6. Practice	Facilities for practice rounds, if any, are at the discretion of the Home Club
7. Finals	The winners will be expected to host the Finals the following year unless they are finalists themselves in which case the venues will be switched with the other Section Finalists.
